CULVERT CHECKLIST

- ___ Completed Permit Application as provided by the Village of Franklin, including:
 - ___ A full identification of the applicant and all interested parties ie: proof of ownership (title insurance), signatures and/or letter of authorization.
 - ___ The residence address and/or business address of applicant, authorized corporation and/or all interested parties.

- ___ A non-refundable application fee of **\$50.00**.
(The application fee shall be credited to the approved permit fee of **\$100.00**)

- ___ A complete written description and location of the property, prepared by a registered civil engineer or land surveyor, on the proposed work to be done.

- ___ A topographical map of the property, covering an area having as radius of 100 feet from the exterior boundary of the subject site as well as property lines and public rights-of-way indicated, prepared by a registered civil engineer or land surveyor.

- ___ A proposed design of the culvert drawn on the topographical map of the property, including the location and inverts of the proposed culvert, the inverts of any nearby culverts, and spot elevations along all nearby ditches and swales.

- ___ A written description of the exact nature of the proposed work done by a registered civil engineer or land surveyor.

- ___ A written description of the kind of equipment proposed to be used for the installation of the culvert.

- ___ A written description of the proposed route to be used over the public streets and/or private property in transporting such materials.

- ___ A written estimate of the time within which such work is to be commenced after permit issuance and a time when it is to be completed.

- ___ Such further information as the Village Engineer or Council may require.

The applicant shall be responsible for 100% of all consultant fees incurred by the Village PLUS a 10% administrative fee.
